I. INTRODUCTION

1. The Office of the Prosecutor (“Prosecution”) submits this communication regarding the disclosure of evidence.

II. CONFIDENTIALITY

2. The Annex, appended to this filing, is classified confidential as it relates to evidence disclosed *inter partes* that should not be released to the public.

III. SUBMISSIONS

3. The Prosecution disclosed to the Defence of Mahamat Said Abdel Kani “Trial INCRIM package 136” containing one item and “Trial Rule 77 package 104” containing twelve items on 18 April 2024.
