The Presidency of the International Criminal Court;

In the application of Mr Jean-Pierre Bemba Gombo (“applicant”) of 9 September 2008 for judicial review of the decision of the Registrar of 25 August 2008 which provisionally determined that the applicant did not benefit in whole or in part from legal assistance paid by the Court, on the grounds that he was not indigent (“Application”);¹

Noting the Presidency’s Decision on this Application (“Decision”)² and the filing of a public redacted version thereof;³

Considering that, in view of the publication of the Decision and noting the information contained therein and the subsequent lapse of time, there is no further reason to retain the confidential classification of both the Application and the “Observations of the Registrar on the ‘Request for Review of the Registrar’s Decision of 25 August 2008 on the Application for Legal Assistance Paid by the Court’ submitted to the Presidency on 9 September 2008” (“Observations”)⁴;

Considering that the Application and the Observations contain personal and financial information which the applicant may wish to redact prior to publication;

Hereby

Orders the applicant to file a public version of the Application (ICC-RoC85-01/08-1-Conf), redacting the following information:

- All monetary figures referred to in paragraphs 11-14;
- The location of the real estate referred to in paragraphs 12 and 13; and

- The identity of the Belgian investigating judge who issued a warrant of arrest for the applicant referred to in paragraph 2 (unless this information is already publicly available).

Orders the Registrar to file a public version of the Observations (ICC-RoC85-01/08-2-Conf), redacting the following information:

- All monetary figures referred to in paragraphs 3, 10 and 12; and
- The location of the real estate referred to in paragraphs 3 and 10.
