I. INTRODUCTION

1. The Prosecution requests the Pre-Trial Chamber to unseal the warrant of arrest issued on 7 January 2019 for Mahamat Nouradine Adam ("Mr ADAM")¹ and issue a public redacted version as proposed in Annex 1.

II. CONFIDENTIALITY

2. This Request is submitted Under Seal, *EX PARTE* in accordance with regulation 23*bis*(1) of the Regulations of the Court ("Regulations") because it refers to information and an order with the same classification.

III. SUBMISSIONS

A. The under seal classification is no longer necessary

- 3. On 7 January 2019, the Chamber issued the warrant of arrest against Mr ADAM.² The Prosecution requests that the warrant be made public because the basis for the under seal classification no longer exists. Despite consultations between the Registry, Prosecution and national authorities, including the competent authorities of the [REDACTED] over the past three years, Mr ADAM's arrest and surrender to the Court have not been achieved.
- 4. The Registry, through the Suspects At Large Working Group, has been consulted by the Prosecution on the merits of unsealing the warrant of arrest and indicated they have no objection for the warrant being unsealed. [REDACTED]⁴,

- 5. On 21 July 2022, the Prosecution informed the [REDACTED] CAR of the planned Request to unseal the warrant of arrest for Mr ADAM. [REDACTED]. Against this background, the under seal classification for the warrant of arrest is no longer necessary to facilitate the arrest and surrender of Mr ADAM.
- 6. At this stage, reclassifying the warrant of arrest as public may facilitate his arrest and surrender as all states will then be aware of its existence. [REDACTED].
 - B. Certain redactions remain necessary to protect witnesses, ongoing investigations and search and seizure operations
- 7. On 11 January 2019, the Prosecution proposed specific redactions to be applied at the time the warrant becomes public.⁷ The Prosecution has revisited its previous submissions and reassessed previously proposed redactions against the backdrop of the status of its investigations and the arrest of Mahamat Said Abdel Kani. Upon this review, the Prosecution proposes a lesser redacted version of the warrant in the event it is made public.
- 8. The Prosecution is of the view that issuing a public redacted version of the warrant of arrest can protect ongoing investigations and will prevent any adverse effects to the protection of victims and witnesses, so far as certain narrowly tailored but important redactions are in place as proposed in Annex 1.
