7 to speak in Arabic I will say so. For example, yesterday with the quotation

8 from the Koran.

Q. [9:42:12] Mr Witness, can you explain what you mean by "cup"? Wouldthis extend to wells?

9 arranging for Koranic classes for children of the local population.

10 Did Ansar Dine provide any other services to the local population?

11 MR GARCIA: [9:54:54](Interpretation) Your Honour?

12 PRESIDING JUDGE MINDUA: [9:54:56](Interpretation) Yes.

13 MR GARCIA: [9:54:56](Interpretation) I'm sorry to intervene once again - I'll

14 try to do this as little as possible - but I disagree with the way that the Defence

15 has represented the witness's remarks from yesterday. This question

16 presupposes that the Ansar Dine group did arrange classes for children. That

17 is not what the witness said. The witness said that -- or he told us about who

18 went to these classes, but nothing more than that. He did not say that the

19 services had been arranged or offered to the people.

20 So if the question could be rephrased or if a direct question could be put;

21 otherwise things become leading and this is -- it's not exactly what the witness

22 told us yesterday.

PRESIDING JUDGE MINDUA: [9:55:54](Interpretation) Indeed. There is
a nuance here, Ms Taylor, compared to what the witness said yesterday and

25 what you are having him say today. Rephrase, please.

1 MS TAYLOR: [9:56:07] Thank you, Mr President. I'm happy to do so, but

2 with the greatest respect, the Prosecutor very well knows the answer to that is

3 in private session in terms of the involvement of Ansar Dine as concerns the

4 Koranic classes. There was a very clear answer given as concerns how those

5 Koranic classes were organised and who paid for them.

6 So I don't believe it's in any way a fair or a representative objection, and it's not

fair to make these objections in public session when the answers are in privatesession.

8 A-L-M-S, not A-R-M-S.

9 MS TAYLOR: [10:02:57] Thank you, that's clearer. It should be "A-L-M-S",

10 which makes sense. So I don't think it's necessary for me to ask the follow-up11 question.

12 Q. [10:03:04] Sorry, Mr Witness, there was a bit of confusion. My follow-up

13 question is, Mr Witness, you said "they" gave gas oil to the farmers. Who or

14 what gave gas oil to the farmers?

15 A. [10:03:55] It was, as I said, Ansar Dine.

16 Q. [10:04:01] Thank you, Mr Witness. If you could just bear with me,

17 sometimes the full answers aren't always clear in the transcripts.

18 Now, Mr Witness, you've described the group receiving and distributing *alms*,

19 that is, *zakat*. How do you know that?

10 to his house, when there was a dispute because I was not there with him. All I

11 do know is that he would inform them, he would explain to them how to

12 resolve the situation; that's all I can tell you.

Q. [10:09:22] And were there any other marabouts performing this role in2012?

A. [10:10:03] I have no idea. I do not know whether there were any other
individuals like him, because I do not know that locality well.

17 Q. [10:10:18] Mr Witness, earlier you mentioned the Malian authorities

18 having the power in Timbuktu. At this time, when you were there in 2012,

19 did you see any Malian authorities present in Timbuktu?

A. [10:11:10] No, in the year 2012, the Malian authorities were no longerthere.

- 17 PRESIDING JUDGE MINDUA: [10:16:17](Interpretation) Mr Prosecutor.

- Q. [10:22:41] You said you "know him by sight." Had you seen him before2012?
- A. [10:23:09] No, I had never seen him before that.
