JUDGE ROSARIO SALVATORE AITALA, acting as Single Judge on behalf of Pre-Trial Chamber II (the "Chamber") of the International Criminal Court (the "ICC"), issues this decision on the Prosecutor's requests to reply.

- 1. On 11 November 2018, the Chamber issued a warrant of arrest against Alfred Yekatom² who was surrendered to the Court on 17 November 2018.
- 2. On 17 December 2018, the Prosecutor submitted the "Prosecution's submission on a Proposed Protocol on the Handling of Confidential Information and Contacts with Witnesses" (the "Prosecutor's Proposed Protocol on Confidential Information")³.
- 3. On 21 December 2018, the Prosecutor submitted the "Prosecution's Request for a Protocol and Redactions" (the "Prosecutor's Proposed Redaction Protocol").⁴
- 4. On 2 January 2019, the Defence submitted the "Expedited request on behalf of Mr. Yekatom seeking a limited extension of time to respond to "Prosecution's submission on a Proposed Protocol on the Handling of Confidential Information and Contacts with Witnesses" and "Prosecution's Request for a Protocol on Redactions" requesting that the Defence be allowed to respond on 7 January 2019, which was granted by the Single Judge the same day *via* email.⁶
- 5. On 7 January 2019, the Defence responded to the Prosecutor's Proposed Protocol on Confidential Information and the Prosecutor's Proposed Redaction Protocol.⁷
- 6. On 10 January 2019, the Prosecutor requested leave to reply on discrete issues emanating from the two Defence responses.⁸
- 7. The Single Judge notes regulation 24(5) of the Regulations of the Court.

a) GRANTS leave to reply to the Defence response relating to the Prosecutor's

Proposed Protocol on Confidential Information and ORDERS the Prosecutor

to reply no later than Wednesday, 16 January 2019, 16:00 hours; and

b) REJECTS the Prosecutor's request for leave to reply to the Defence response

relating to the Prosecutor's Proposed Redaction Protocol.
