THE JUDGES OF PRE-TRIAL CHAMBER I (the "Chamber") of the International Criminal Court issue the present decision on the election of the Presiding Judge.

- 1. On 13 March 2015, the Presidency, based on rule 4*bis* (2) of the Rules of Procedure and Evidence, assigned judges to divisions, whereby *inter alia* Judge Cuno Tarfusser, Marc Perrin de Brichambaut and Judge Chang-ho Chung were assigned to the Pre-Trial Division, in accordance with article 39(1) of the Rome Statute (the "Statute").<sup>1</sup>
- 2. On 16 March 2015, the Presidency constituted the Chamber anew and assigned the situation in Kenya to the Chamber.<sup>2</sup>
- 3. The Judges of the Chamber note regulation 13(2) of the Regulations of the Court, pursuant to which the judges of each Pre-Trial Chamber shall elect from amongst their members a Presiding Judge.
- 4. The Judges of the Chamber also note the meeting of judges on 24 March 2015 during which it was decided that Judge Cuno Tarfusser will act as the Presiding Judge of the Chamber with immediate effect.
