TRIAL CHAMBER IV ('Chamber') of the International Criminal Court, in the case of *The Prosecutor v. Abdallah Banda Abakaer Nourain*, pursuant to Regulation 13(2) of the Regulations of the Court (the 'Regulations'), issues this 'Decision Notifying the Election of the Presiding Judge'.

- 1. On 18 June 2018, the Chamber, in its previous composition, informed the parties and participants that it has elected Judge Prost to preside over the Chamber.¹
- 2. On 16 March 2021, the Presidency recomposed the Chamber, assigning Judges Reine Alapini-Gansou, Kimberly Prost, and María del Socorro Flores Liera to it.²
- 3. Pursuant to Regulation 13(2) of the Regulations, the Judges of the Chamber, in its new composition, elected a Presiding Judge and **HEREBY DECIDE** that Judge Kimberly Prost is the Presiding Judge.
