Noting the terms of regulation 46, sub regulation 2 of the Regulations of the Court, pursuant to which "[t]he Presidency shall assign a situation to a Pre-Trial Chamber as soon as the Prosecutor has informed the Presidency in accordance with regulation 45";

Noting the decision reconstituting Pre-Trial Chamber II, issued by the Presidency on 29 April $2009:^{1}$

Decides to assign the situation in the Republic of Kenya to Pre-Trial Chamber II with immediate effect.
