THE PRESIDENCY of the International Criminal Court ("Court");

NOTING article 38 of the Rome Statute of the International Criminal Court ("Statute");

**NOTING** its decision of 20 May 2011 assigning the Situation in the Republic of Côte d'Ivoire to Pre-Trial Chamber II;<sup>1</sup>

**CONSIDERING** that the functions of a Pre-Trial Chamber shall normally be carried out by three judges of the Pre-Trial Division or by a single judge of that division in accordance with article 39(2)(b)(iii) of the Statute;

**CONSIDERING** also article 39(4) of the Statute, pursuant to which the Presidency may temporarily attach a judge from the Trial Division to the Pre-Trial Division or vice versa if it considers that the efficient management of the workload of the Court so requires;

NOTING article 39 of the Statute and regulation 46 of the Regulations of the Court;

#### HEREBY:

**DECIDES** to temporarily attach Judge Odio Benito and Judge Fulford, currently assigned to the Trial Division, to the Pre-Trial Division;

**DECIDES** to constitute Pre-Trial Chamber III;

**DECIDES** that Pre-Trial Chamber III shall be composed as follows:

- Judge Odio Benito

**DECIDES** that the situation in the Republic of Côte d'Ivoire shall be re-assigned to Pre-Trial Chamber III with immediate effect; and

**ORDERS** the Registrar to file and notify this decision to the relevant parties and participants in the situation.
