## The Registrar of the International Criminal Court ("the Court");

**NOTING** the decision of Pre-Trial Chamber II (the "Chamber") notified on 24 March 2009 designating Judge Hans-Peter Kaul as Single Judge responsible for all the issues arising in connection with victims' participation in the proceedings in respect to the situation in Uganda (the "Situation") and in the case of *The Prosecutor v. Joseph Kony, Vincent Otti, Okot Odhiambo and Dominic Ongwen* (the "Case");<sup>1</sup>

**NOTING** the Single Judge's decision notified on 12 March 2012 on victims' participation in proceedings related to the Situation (the "Decision of 12 March 2012") in which he, *inter alia*, appoints the Office of Public Counsel for Victims (the "OPCV") as legal representative of all victims and victim applicants pending appointment of a common legal representative;<sup>2</sup>

**CONSIDERING** that the Registry has received to date a total of 1,136 applications for participation and/or reparations in relation to the situation in Uganda;<sup>3</sup>

**NOTIFIES** the parties and participants that the OPCV represents all victims and victim applicants listed in annex 1 pending the appointment of a common legal representative, in accordance with the Decision of 12 March 2012.
