Trial Chamber II ("Chamber") of the International Criminal Court ("the Court") in the case of *Prosecutor v. Germain Katanga* ("Katanga case" or "the case"), issues the following decision notifying the election of a Presiding Judge.

- On 16 April 2014, the Presidency of the Court issued a decision replacing two judges in Trial Chamber II whereby it reconstituted the Chamber and decided that such reconstitution should be effective on the date of the issuance of the article 76 decision.<sup>1</sup>
- 2. On 23 May 2014, the Chamber issued the article 76 decision.<sup>2</sup>
- The Chamber, in its reconstituted composition, has elected the Presiding Judge pursuant to regulation 13(2) of the Regulations of the Court.
