THE REGISTRAR of the International criminal Court (the “Court”)

NOTING the “*Decision Pursuant to Article 61(7)(a) and (b) of the Rome Statute on the Charges of the Prosecutor Against Bosco Ntaganda*”¹, issued by the Pre-Trial Chamber II (the “Chamber”) on 9 June 2014;

NOTING the “*Third Decision on Bosco Ntaganda’s Interim Release*”² (the “Decision”) issued by the Chamber on 17 July 2014;

NOTING Rule 129 of the Rules of Procedure and Evidence and Regulation 23bis (1) of the Regulations of the Court;

CONSIDERING that in the Decision, the Chamber “*orders the Registrar to transmit, [...], the Confirmation of Charges Decision together with the record of the case against Bosco Ntaganda to the Presidency to constitute a Trial Chamber*”³;

CONFIRMS that the Presidency has been provided with electronic access to the record of the proceedings;
