I. INTRODUCTION

1. The Government of the Republic of Kenya hereby respectfully submits its update as directed in the Trial Chamber's *'Decision on Prosecution's applications for a finding of non-compliance pursuant to Article 87 (7) and for an adjournment of the provisional trial date'*¹ ('the Decision') wherein the Chamber stated thus:

'DIRECTS the Prosecution and the Kenyan Government to file submissions updating the Chamber regarding the status of execution of the Revised request and the status of related consultations, as applicable, on 30 April 2014 with further updates due thereafter on a two-monthly basis;²

2. Following a consultative meeting held [REDACTED] between the Government of the Republic of Kenya and the Office of the Prosecutor ('the Prosecution'), as stated in *'the Government of the Republic of Kenya's First Update to the Trial Chamber Pursuant to the "Order further extending deadline for filing of first update due on 30 April 2014"'*³ ('the First Update'), the parties agreed on the modalities of the implementation of the Prosecution's revised request for assistance dated 8 April 2014 ('Revised Request')⁴, which agreement was captured in the First Update.
3. At this point the Government of the Republic of Kenya wishes to state the progress it has made on the implementation of the Revised Request since its First Update to the Chamber.
