**Trial Chamber VI** ('Chamber') of the International Criminal Court ('Court'), in the case of *The Prosecutor v. Bosco Ntaganda*, having regard to Articles 64 and 68 of the Rome Statute, and Regulation 34 of the Regulations of the Court, issues the following 'Order amending the schedule for the presentation of victims' views and concerns'.

1. On 10 February 2017, the Chamber issued a decision, in which it, *inter alia*, authorised six victims ('Victims') to present their views and concerns, and scheduled that such presentation be given, by video-link, on 2 and 3 March 2017 ('Decision').<sup>1</sup> The Chamber also directed the Legal Representative of Victims of the Attacks ('LRV') to file any requests for measures pursuant to Rule 87 or 88 of the Rules for these victims by 20 February 2017, and the parties to file any response to such requests by 28 February 2017.<sup>2</sup>

2. On 17 February 2017, the LRV filed a request for in-court protective and special measures for three of the six Victims ('Protective Measures Request').<sup>3</sup>

3. On 20 February 2017, in accordance with the deadline set out in the Decision,<sup>4</sup> the LRV provided the identifying information concerning the authorised victims.<sup>5</sup>

4. On 22 February 2017, the Registry informed the Chamber of logistical difficulties<sup>6</sup> requiring the presentation of the Victims' views and concerns to be rescheduled. Noting that the proposed new schedule would only entail bringing

forward the hearings by one day, and thus shall not unduly impact the Victims, or the parties and participants, the Chamber therefore amends the schedule as set out in the Decision and directs that the presentation of views and concerns will take place on 1 and 2 March 2017.


5. In addition, in order to allow for the Chamber's decision on the Protective Measures Request to be issued in a timely manner, the Chamber considers it appropriate to shorten the deadline for any responses to the aforementioned request by one day.

**THE CHAMBER HEREBY**

**DIRECTS** that the hearing for the presentation of views and concerns by the Victims will take place on 1 and 2 March 2017; and

**DIRECTS** that any response to the Protective Measures Request be filed by 27 February 2017.


