## Introduction

1. The Registry informs the Chamber of the appointment of Mr. Árpád Béla Gyula Tivadar (Julius) von Bóné as Legal Adviser to Witness P-0142 (“Notification of Appointment”), pursuant to rule 74 (10) of the Rules of Procedure and Evidence ( “Rules”).

## Classification

2. The present submission is classified public and annexes are classified confidential, pursuant to regulation 23*bis*(1) of the Regulations of the Court (“RoC”), because they contain the identity or private contact details of Mr. Árpád Béla Gyula Tivadar (Julius) von Bóné.

## Applicable Law

3. The Registry has considered the following provisions: article 68 of the Rome Statute, rules 21 and 74(10) of the Rules, regulations 67 and 69 of the RoC, regulation 123(1) of the Regulations of the Registry, and articles 5, 8 and 22(3) of the Code of Professional Conduct for Counsel ( “Code”).

## Submission

4. On 23 February 2017, the Registrar appointed Mr. Árpád Béla Gyula Tivadar (Julius) von Bóné as the Legal Adviser to Witness P-0142.<sup>1</sup>
5. Ms von Boné was duly provided with electronic access to relevant material in connection with the case, including the statements and transcripts of

interviews of Witness P-0142, *via* a secure channel in order to maintain confidentiality at all times.<sup>2</sup>

6. On 6 March 2015, Mr von Boné executed the solemn undertakings required by articles 5 and 22(3) of the Code.<sup>3</sup>
