Section

I. Introduction

1. This report is submitted pursuant to the "Corrigendum of "Orders to the Registrar concerning action to be taken in case of information relating to travel of suspects"" issued by Pre-Trial Chamber II ("Chamber") on 15 April 2015, in which the Chamber ordered the Registry "to prepare a report on the information received as regards travels, whether planned or ongoing, by persons at large for whom a warrant of arrest has been issued by the Court and the action taken in respect of it, as well as on any follow-up which might be received from States, to be filed in the relevant case record, as appropriate."¹

II. Classification

2. Pursuant to regulation 23bis(1) of the Regulations of the Court ("RoC"), nine annexes are submitted as confidential as they refer to the names of staff members from the International Criminal Court, the Embassy and/or the Permanent Missions of the requested States.

III. Submissions

A. <u>Visits to Non-States Parties</u>

Visit of Mr Al Bashir to the Arab Republic of Egypt:

- 3. As reported by the media, Mr Omar Hassan Ahmad Al Bashir ("Mr Al Bashir") travelled to the Arab Republic of Egypt to co-chair the Joint High Presidential Committee, which took place on 5 October 2016, as well as to attend the "Egyptian October victory celebrations" on 6 October 2016 (Annex 1).
- 4. On 3 October 2016, the Registry transmitted a note verbale to the Arab Republic of Egypt renewing its invitation to cooperate with the immediate arrest and surrender of Mr Al Bashir to the Court (Annex 2).

5. To date, no reply to the above mentioned note verbale has been received from the authorities of the Arab Republic of Egypt.

Visit of Mr Al Bashir to the State of Qatar:

- 6. Media reports indicated that Mr Al Bashir travelled to the State of Qatar on 31 October 2016 in order to present his condolences on the passing of His Highness Sheikh Khalifa bin Hamad Al Thani (Annex 1).
- 7. On 31 October 2016, the Registry transmitted a note verbale renewing its invitation to the authorities of the State of Qatar to cooperate with the arrest of Mr Al Bashir to the Court (Annex 3).
- 8. To date, no reply to the above mentioned note verbale has been received from the authorities of the State of Qatar.

Visits of Mr Al Bashir to the Kingdom of Saudi Arabia:

- 9. As reported by the media, Mr Al Bashir travelled to the Kingdom of Saudi Arabia on 24 October 2016 at the invitation of H.E Salman bin Abdulaziz Al Saud, King of Saudi Arabia (Annex 1).
- 10. On 24 October 2016, the Registry transmitted a note verbale inviting the authorities of the Kingdom of Saudi Arabia to provide information regarding the above mentioned visit, and renewing its invitation for cooperation with the Court in the arrest and surrender of Mr Al Bashir (Annex 4).
- 11. Media reports also indicated that Mr Al Bashir travelled to the Kingdom of Saudi Arabia on 23 January 2017 for a meeting with H.E. Salman bin Abdulaziz Al Saud, King of Saudi Arabia and a number of State representatives (Annex 1).
- 12. On 23 January 2017, the Registry transmitted a note verbale renewing its invitation to the authorities of the Kingdom of Saudi Arabia to cooperate with the Court in the arrest of Mr Al Bashir (Annex 4).

13. To date, no reply to the above mentioned notes verbales, dated 24 October 2016 and 23 January 2017 respectively, have been received from the authorities of the Kingdom of Saudi Arabia.

Visit of Mr Al Bashir to the Kingdom of Morocco:

- 14. As reported by the media, King Mohammed VI invited Mr Al Bashir to attend the 22nd United Nations Climate Change Conference that was scheduled to take place from 7 to 18 November 2016 (Annex 1).
- 15. On 3 November 2016, the Registry transmitted a note verbale renewing its invitation to the Moroccan authorities to cooperate with the Court in the arrest of Mr Al Bashir (Annex 5).
- 16. To date, no reply to the above mentioned note verbale has been received from the authorities of the Kingdom of Morocco.

Visits of Mr Al Bashir to the Federal Democratic Republic of Ethiopia:

- 17. Media reports indicated that Mr Al Bashir travelled to the Federal Democratic Republic of Ethiopia for an African Union High-Level emergency meeting on 9 November 2016 (Annex 1).
- 18. The Registry did not take any action with regards to the travel of Mr Al Bashir to the Federal Democratic Republic of Ethiopia, having been informed only after the visit had been concluded.
- 19. Media reports also indicated that Mr Al Bashir travelled to the Federal Democratic Republic of Ethiopia to take part in a summit of the Intergovernmental Authority on Development (IGAD) which took place on 9 December 2016 (Annex 1).
- 20. On 9 December 2016, the Registry transmitted a note verbale to the Federal Democratic Republic of Ethiopia, renewing its invitation to cooperate by immediately arresting and surrendering Mr Al Bashir to the Court (Annex 6).

- 21. During the 28th African Union Summit which took place from 22 to 31 January 2017, media reports indicated that Mr Al Bashir travelled to the Federal Democratic Republic of Ethiopia to attend (Annex 1).
- 22. On 30 January 2017, the Registry transmitted a note verbale to the Federal Democratic Republic of Ethiopia, renewing its invitation to cooperate in the immediate arrest and surrender of Mr Al Bashir to the Court (Annex 6).
- 23. On 4 April 2017, media reports indicated that Mr Al Bashir travelled to the Federal Democratic Republic of Ethiopia to attend a meeting with Prime Minister Hailemariam Desalegn and other government officials in Addis Ababa (Annex 1).
- 24. To date, no reply to the above mentioned note verbales has been received from the authorities of the Federal Democratic Republic of Ethiopia.

Visit of Mr Al Bashir to the Republic of Equatorial Guinea:

- 25. As reported by the media, Mr Al Bashir travelled to the Republic of Equatorial Guinea to attend the 4th Africa-Arab Summit that took place on 24 November 2016 (Annex 1).
- 26. On 21 November 2016, the Registry transmitted a note verbale to the Republic of Equatorial Guinea inviting the authorities to provide information regarding the above mentioned visit, as well as to cooperate with the provisional arrest of Mr Al Bashir (Annex 7).
- 27. On 1 December 2016, the Registry transmitted a request to the Republic of Equatorial Guinea for the arrest and surrender of Mr Al Bashir dated 24 November 2016 (Annex 7).
- 28. To date, no reply to the above mentioned notes verbales, dated 21 November 2016 and 1 December 2016 respectively, has been received from the authorities of the Republic of Equatorial Guinea.

Visits of Mr Al Bashir to the United Arab Emirates:

- 29. As reported by the media, Mr Al Bashir travelled to the United Arab Emirates on 28 November 2016 to conduct a multi-day visit on bilateral relations between the two countries (Annex 1).
- 30. On 27 November 2016, the Registry transmitted a note verbale to the United Arab Emirates inviting the authorities to proceed with the immediate arrest and surrender of Mr Al Bashir (Annex 8).
- 31. Media reports also indicated that Mr Al Bashir travelled to the United Arab Emirates to participate in the 13th International Defence Conference that took place from 19 to 23 February 2017 (Annex 1).
- 32. On 16 February 2017, the Registry transmitted a note verbale to the United Arab Emirates, renewing its invitation to cooperate by immediately arresting and surrendering Mr Al Bashir to the Court (Annex 8).
- 33. To date, no reply to the above mentioned note verbales has been received from the authorities of the United Arab Emirates.

B. <u>Visit to a State Party</u>

Visit of Mr Al Bashir to the Hashemite Kingdom of Jordan:

- 34. On 10 January 2017, the Registry was alerted of a potential visit of Mr Al Bashir to the Hashemite Kingdom of Jordan in order to participate in the 28th Arab League Summit, scheduled to take place in Amman on 29 March 2017 (Annex 1).
- 35. On 21 February 2017, the Registry transmitted a note verbale to the Hashemite Kingdom of Jordan, inviting the Jordanian authorities to provide information regarding the above mentioned visit, and renewing its request to cooperate in the arrest and surrender of Mr Al Bashir to the Court if he entered the territory of the Hashemite Kingdom of Jordan.²

- 36. On 24 March 2017, the Registry transmitted a note verbale to the Chamber from the Hashemite Kingdom of Jordan.³
- 37. On 28 March 2017, the Registry transmitted a second note verbale to the Chamber from the Hashemite Kingdom of Jordan.⁴
- 38. To date, the Registry has not received any further information regarding the travel of Mr Al Bashir to the Hashemite Kingdom of Jordan.
