### I. Introduction

1. In accordance with rules 13(1) and 176(2) of the Rules of Procedure and Evidence, the Registry hereby transmits, as an annex to the present transmission, a note verbale (Ref. No. E15/574) from the Embassy of the Hashemite Kingdom of Jordan to the Kingdom of the Netherlands dated 30 June 2017.

#### II. Procedural history

- 2. In its decision issued on 26 April 2017, the Pre-Trial Chamber II ("Chamber") invited the Hashemite Kingdom of Jordan, "if it wishes to provide further submissions concerning its failure to arrest and surrender Omar Al-Bashir while present on the territory of the Hashemite Kingdom of Jordan, to file any such submissions by Friday, 26 May 2017."<sup>1</sup>
- 3. On 2 June 2017, following an application by the Hashemite Kingdom of Jordan to extend the time limit ordered by the Chamber,<sup>2</sup> the Chamber extended the time limit to provide any further submissions until Friday 30 June 2017.<sup>3</sup>
