Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber IX ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Dominic Ongwen*, having regard to Article 68(3) of the Rome Statute, Rules 85 and 89 of the Rules of Procedure and Evidence and Regulation 34 of the Regulations of the Court, issues the following 'Decision on LRV Request Concerning the Deaths of Participating Victims'.

- 1. On 16 August 2017, the team of external legal representatives of victims ('LRV') notified the Chamber that seven participating victims in the case had died since January 2016 ('Request').¹ The LRV requests that the Chamber: (i) recognise these deaths and, if it so wishes, order the Registry to file an updated consolidated list of participating victims² and (ii) recognise that the reparations requests made by these victims are not extinguished by their deaths and may be continued on their behalf by appropriate successors.
- 2. No responses to the Request were filed.
- 3. The Single Judge recalls the applicable procedure for admission of victims to participate in the present case.³ The Single Judge also notes the Court's resumption of action jurisprudence, whereby closely-connected individuals may continue the action initiated by a participating victim who dies. To resume the action on behalf of a deceased victim, an applicant must provide sufficient evidence: (i) of the death of the victim; (ii) of his or her relationship to the victim; and, at least where the applicant cannot easily be presumed to be entitled to

resume the action, (iii) demonstrating his or her appointment by the deceased victim's family members.⁴

- 4. The Single Judge notes that the LRV does not advance any concrete resumption of action applications at this time. However, by way of the relief sought in the Request, the LRV effectively seeks guidance as to how deceased victims and resumptions of action will be recognised in this case. Going forward, the Single Judge sets the following procedure:
 - (i) When a participating victim dies, the victim's legal representative is to inform the Victims Participation and Reparations Section ('VPRS'). The VPRS is then to amend the consolidated list of participating victims accordingly. The VPRS need not formally file an updated list each time an amendment is required, but an updated consolidated list must be so filed at least twice per calendar year until the conclusion of the proceedings before this Chamber.
 - (ii) Resumption of action applications, including the necessary supporting materials, must be provided to the VPRS. The VPRS is then to transmit them to the Chamber and, at the same time, to the Office of the Prosecutor, defence for Mr Ongwen and legal representatives of victims. Redactions may be applied to the versions transmitted as necessary.
 - (iii) The time limit for any specific objections to the resumption of action is set at 14 days from notification of the relevant application(s).
 - (iv) In case any objection is raised, the Single Judge will assess the contested application. Conversely, and unless otherwise ordered, when no objection is raised the resumption of action is granted.
 - (v) Any granted resumption of action must be reflected in the updated list specified in point (i) above.
