The three judges of the Appeals Chamber of the International Criminal Court,

In the review by the Court concerning reduction of sentence of Mr Thomas Lubanga Dyilo pursuant to article 110 of the Statute,

Recalling that, on 7 August 2017, the three judges appointed by the Appeals Chamber (“Panel”) issued the “Scheduling Order for the second review concerning reduction of sentence of Mr Thomas Lubanga Dyilo” (ICC-01/04-01/06-3346) (“7 August 2017 Scheduling Order”), wherein the Panel set out the deadlines for the submission of written representations,

Noting that, on 4 September 2017, the Registry filed its written representations, in which it included an exchange of emails between it and the government of the Democratic Republic of the Congo (“DRC”) that indicated that the DRC would only be able to file its written representations by 8 September 2017,

Considering that, in the Panel’s view, the DRC government’s representations are of importance for deciding the matter before it,

Decides to modify the deadlines for the submission of written representations set out in the 7 August 2017 Scheduling Order,

Decides that all other instructions contained in the 7 August 2017 Scheduling Order remain applicable, and

Issues the following

SCHEDULING ORDER

1. The Democratic Republic of the Congo is invited to file its written representations by 8 September 2017;
2. Mr Thomas Lubanga Dyilo, the Prosecutor, the Legal Representatives of Victims V01, the Legal Representatives of Victims V02, and the OPCV are invited to file their written representations by 14 September 2017; and
3. Mr Thomas Lubanga Dyilo, the Prosecutor, the Legal Representatives of Victims V01, the Legal Representatives of Victims V02, and the OPCV are invited to file written responses by 21 September 2017.
