Transmission

- 1. Pursuant to paragraph 4(i) of Trial Chamber IX's "Decision on LRV Request Concerning the Deaths of Participating Victims" ("Decision") issued on 30 August 2017,¹ the Registry hereby transmits, as an annex to this filing, an updated consolidated list of the participating victims in the *Ongwen* case ("List").
- 2. The Registry notes that no resumption of action applications have been transmitted to the Registry since the issuance of the Decision.
- 3. The List, which takes into account the death of 7 participating victims notified to the Chamber on 16 August 2017 by the team of external legal representatives of victims ("LRVs"), ² reflects all 4,100 victims currently participating in the proceedings.³
- 4. Pursuant to the Decision, the Registry will in the future transmit the List in an updated version at least twice per calendar year until the conclusion of the proceedings before the Chamber.⁴
