TRIAL CHAMBER II of the International Criminal Court ("Chamber") orders as follows:

- 1. On 21 October 2016, the Chamber approved the proposed plan of the Trust Fund for Victims ("Trust Fund") in relation to symbolic collective reparations.¹ In its Order, it instructed the Trust Fund to submit to the Chamber, every three months, a progress report on the implementation of symbolic collective reparations detailing the exact steps it has undertaken.²
- 2. On 8 December 2016, the Chamber instructed the Trust Fund to submit to it collective reparations proposals by 13 February 2017.³
- 3. On 23 January 2017, the Trust Fund submitted the first report on the implementation of symbolic collective reparations⁴ and, on 13 February 2017, it submitted its collective reparations proposals.⁵
- 4. On 6 April 2017, the Chamber approved the first stage of the Trust Fund's proposed plan of 13 February 2017 in relation to collective reparations, namely the selection of implementing partners for collective reparations. In this connection, it instructed the Trust Fund to report to the Chamber on the results of the process for selecting implementing partners, and to consult the Chamber before finalizing the contracts with the selected partners.

- 5. On 21 April 2017, the Trust Fund submitted the second progress report on the implementation of symbolic collective reparations.⁸
- 6. Since 21 April 2017, no information on progress made in the implementation of collective reparations which includes symbolic collective reparations has been imparted to the Chamber.

FOR THESE REASONS, the Chamber

INSTRUCTS the Trust Fund to report to the Chamber by 15 November 2017 on the progress made in the implementation of collective reparations, including symbolic collective reparations.
