I. Introduction

 The Registry hereby informs the Chamber of the appointment of Mr Amos Waldman as Legal Adviser to Witness P-0406 ("Notification of Appointment"), pursuant to rule 74 (10) of the Rules of Procedure and Evidence ("Rules").

II. Classification

2. Pursuant to regulation 23 *bis*(1) of the Regulations of the Court ("RoC"), the annexes to the present submission are classified as confidential, as they contain personal information and contact details of Mr Amos Waldman.

III. Applicable Law

IV.Submissions

4.
