I. Introduction

 Pursuant to Pre-Trial Chamber III's "Order to the Victims Participation and Reparation Section Concerning Victims' Representations" of 9 November 2017 ("Chamber" and "Order of 9 November 2017"),¹ the Registry submits the present report on victims' representations, together with its assessment of these representations ("Annex I") and a list with some factual details on the major incidents reported in the representations ("Annex II").

II. Procedural History

- 2. In its Order of 9 November 2017, the Chamber ordered the Victims Participation and Reparations Section ("VPRS") to: "(i) identify, to the extent possible, the community leaders of the affected groups to act on behalf of those victims who may wish to make representations; (ii) receive and collect victims' representations, be it collective or individual; (iii) conduct a preliminary assessment on whether the conditions set out in rule 85 of the Rules of Procedure and Evidence ["Rules"] have been met; and (iv) transmit incoming representations on a rolling basis, possibly every two weeks, together with a brief preliminary assessment".²
- 3. On 7 December 2017, the Registry transmitted to the Chamber the first batch of victims' representation forms received and its first report thereon ("First Report on Representations").³
- 4. On 21 December 2017, 11 and 25 January, and 2 and 5 February 2018, the Registry transmitted to the Chamber the second to sixth batches of

representations received and its second to sixth reports on victims' representations.⁴

 On 9 February 2018, the Registry transmitted to the Chamber the seventh and last batch of representations received.⁵

III. Classification

6. Pursuant to regulation 23bis(1) of the Regulations of the Court ("RoC"), the annexes to the present document are classified as "confidential *ex parte*, only available to the Registry", because they contain confidential information that may lead to the identification of potential victims.

IV. Applicable Law

7. The Registry submits the present report in accordance with articles 15(3) and 68(1) of the Rome Statute, rules 16(1) and 85 of the Rules, regulation 23*bis*(1) of

the RoC and regulation 102 of the Regulations of the Registry.

V. Submissions

A. Victim representation forms received

- 8. The present report is based on 309 victim representation forms submitted on behalf of approximately 2,250 individual victims, an organisation representing a large group of victims⁶ and 809 families⁷. 98 out of the 309 victim representation forms were submitted online, 210 were sent *via* email, some of them by interlocutors that the VPRS had previously met during its information and training sessions, and one form was sent by post. 237 of the 309 representation forms are collective.
- 9. Three collective representations, submitted on behalf of 13 individuals, indicate that the victims represented therein do not want the ICC Prosecutor to investigate the violence associated with the conflict in Afghanistan. In three collective representations, submitted on behalf of 24 individuals, questions 9 to 11 were not answered. Moreover, from the information included in one collective representation introduced on behalf of 150 individuals, it is unclear

whether the victims want or do not want an investigation to commence. All other victims are in favour of the Prosecutor's request for authorisation of an investigation⁸. This information is outlined in more detail in Annex I.

- 10. The Registry notes that the total number of victim representation forms received in the context of the Afghanistan situation is 794, out of which 41 forms have been assessed by the VPRS as duplicates.
- 11. The Registry further submits that 54 representations out of the 794 representations received have been assessed by the VPRS as not meeting the conditions set out in rule 85 of the Rules.⁹ These representations are not included in this report. The VPRS stands ready to report in detail on the said forms including their legal analysis upon the Chamber's request.

B. Rule 85 Preliminary Legal Assessment by the Registry

12. In accordance with the Order of 9 November 2017, the VPRS conducted a preliminary legal assessment of each representation form in order to assess whether the individual or group making the representation falls within the definition of victim under rule 85 of the Rules. A detailed explanation of the assessment criteria applied by the Registry has been submitted together with the First Report on Representations; a supplemental explanation was submitted together with the Fifth Report on Representations.¹⁰

- 13. Out of the total number of 794 representations received, 575 forms were received between 25 and 31 January 2018 and 12 forms were received after the deadline. 409 out of these 587 forms required translation from Dari and Pashto.¹¹
- 14. In Annex II to the present report, the VPRS prepared a list of those incidents described in the victim representation forms that have also been reported by the UNAMA in their public reports and/or by other NGOs and main media outlets. The VPRS compiled a short paragraph regarding factual details of major incidents that are referred to in the representation forms and for which research in the sources mentioned above yielded relevant information. In order to further facilitate the Chamber's consideration of the representations submitted, the VPRS listed in Annex II all representations that refer to any of the incidents at the beginning of the description of each such incident. The individual legal assessment in Annex I contains references (in red) to relevant paragraphs in Annex II for ease of (cross-)reference.
