I. PROCEDURAL BACKGROUND

- 1. On 2 February 2018, the Common Legal Representative submitted her Final List of Witnesses and her Request for Leave to Present Evidence.¹ On the same day, the Legal Representatives filed their request for leave to present evidence and to present victims' views and concerns in person.² On 15 February 2018, the Defence filed its Response to both Legal Representatives of victims' requests to present evidence.³
- 2. On 6 March 2018, the Chamber rendered its Decision authorising the presentation of evidence by both teams of Legal Representatives of Victims, ordering the latter, *inter alia*, to provide certain information within one week after the Prosecution's formal notice that it concluded its evidence presentation.⁴
- 3. On 14 March 2018, by e-mail, the Chamber modified the original deadline indicating that the Legal Representatives should provide said information by 5 April 2018.5
- 4. The Common Legal Representative hereby provides the Chamber with the requested information.

II. CONFIDENTIALITY

5. Pursuant to regulation 23*bis*(1) of the Regulations of the Court, Annex B is filed confidential since it contains confidential information.

III. INFORMATION PROVIDED TO THE CHAMBER

- 6. The Common Legal Representative confirms her final List of Witnesses contained in Annex A and her List of Evidence contained in Confidential Annex B. In relation to the List of Evidence, she indicates that pending the determination of the Chamber on her request to introduce one item through the "Bar Table", said item is not included in the List. Should the Chamber grant the request, an updated List of Evidence will be filed immediately.
- 7. The Common Legal Representative certifies that all necessary witness information forms have been completed and provided to VWU on 23 March 2018. All witnesses will testify publicly. Therefore, no request for protective and/or special measures was filed.
- 8. The Common Legal Representative attaches the summaries of the anticipated testimonies in Annex C to the present submission. In this regard, she indicates that the Acholi translations have been requested on 27 March 2018 and that the Languages Services Section within the Registry has indicated that translation will be ready on 6 April 2018. The Acholi translations will be disclosed to the Defence as soon as received.
- 9. The Common Legal Representative informs the Chamber that she has disclosed to the parties and the other Legal Representative's team, the Experts' Reports and related documents, as well as the items she intends to use during the

evidence presentation, which are included in the List of Evidence. In this regard, the Common Legal Representative indicates that the items she intends to use are mainly articles and papers quoted in the Experts' Reports or that she has found relevant and publicly available. Because of the fact that the final Experts' Reports were received very recently (the last one on 28 March 2018), she is not in a position to exhaustively list all the items which could potentially be of use during her questioning. Therefore, the Common Legal Representative may seek the Chamber's indulgence to allow her to amend this List at the approaching appearance of the witnesses within the deadline for submitting such items as set out in the "Initial Directions on the Conduct of the Proceedings". A formal notice of disclosure is filed concomitantly.
