## Transmission

1. Pursuant to paragraph 4(i) of Trial Chamber IX's ("Chamber") "Decision on LRV Request Concerning the Deaths of Participating Victims", issued on 30 August 2017,<sup>1</sup> the Registry transmitted on 15 December 2017, a first consolidated list of participating victims in the case of *The Prosecutor v. Dominic Ongwen* ("Ongwen case").<sup>2</sup>
2. Pursuant to the recent order of the Chamber,<sup>3</sup> the Registry hereby transmits, as an annex to this filing, an updated consolidated list of the participating victims in the *Ongwen* case ("Updated List") which takes into account the change in legal representation of one participating victim.<sup>4</sup>
3. The Updated List reflects all 4,100 victims currently participating in the proceedings.<sup>5</sup>
