Section

- 1. On 27 August 2018, the Appeals Chamber issued its "Order on the conduct of the hearing before the Appeals Chamber in the Jordan Referral re Al-Bashir Appeal" ("Order").
- 2. On 29 August 2018, Jordan transmitted a *note verbale* to the Registry referring to the Order and requesting: (i) an extension of the allotment of time to make its statements on the Groups A, B and C issues at the hearing; and (ii) a precise schedule of the hearing.²
- 3. The Prosecution understands Jordan's first request to mean a request to double the amount of time to be allotted to Jordan to make its submissions on the Groups A, B and C issues (*i.e.*, to increase the times allotted to Jordan in the Order under the heading "Groups A and B" from 30 minutes to 60 minutes (for a total of 120 minutes), and under the heading "Group C" from 20 minutes to 40 minutes). To the extent the Prosecution's understanding is correct, the Prosecution does not oppose this request. Should the Chamber be minded to grant Jordan the requested extension of time, the Prosecution asks that, in the interests of fairness, it be granted a corresponding extension of time to make its submissions on the Groups A, B and C issues.
