Registrar Other Mr Peter Lewis Pre-Trial Chamber II THE PRESIDENCY of the International Criminal Court notes that on 8 June 2018, the Appeals Chamber discontinued proceedings against Mr Jean-Pierre Bemba Gombo in respect of certain crimes and acquitted him in respect of all remaining charges brought against him in

the case;1

NOTING that on 22 October 2018, the Presidency received 'Mr. Bemba's request for a variation of the time and page limits in relation to a claim under article 85 of the Statute' (the 'Request');

RECALLING article 85 of the Rome Statute of the International Criminal Court (the 'Statute') and rules 173-175 of the Rules of Procedure and Evidence (the 'Rules');

CONSIDERING that the reference to 'request' in rule 173(1) of the Rules encompasses procedural requests associated with an application for compensation pursuant to article 85 of the Statute;

NOTING that, in view of the confidential and *ex parte* classification of the Request, the Presidency considers that the present decision should remain confidential until such time that the Chamber designated below has the opportunity to consider the appropriate level of classification of the Request;

HEREBY DESIGNATES Pre-Trial Chamber II as the Chamber to consider the Request, as well as any eventual request for compensation under article 85 of the Statute, pursuant to rule 173(1) of the Rules, without prejudice to any determination by the Chamber on the admissibility and/or merits of the Request;

HEREBY ORDERS the Registrar to notify the Request to Pre-Trial Chamber II.
