### I. Introduction

1. The Registry submits the present report and its annexes consisting of documents which have been transferred, registered and re-stamped in the case *Prosecutor v. Alfred Yekatom and Patrice-Edouard Ngaïssona*, pursuant to the "Decision on the joinder of the cases against Alfred Yekatom and Patrice-Edouard Ngaïssona and other related matters" ("Decision"), issued on 20 February 2019 by Pre-Trial Chamber II ("Chamber").

# 2. Pursuant to the Decision, the Registry was ordered to:

- rename the record of the case of *Prosecutor v. Alfred Yekatom* to *Prosecutor v. Alfred Yekatom and Patrice Edouard Ngaïssona* while retaining the case record number as ICC-01/14-01/18;
- transfer all documents contained in the record of the case of Prosecutor v. Patrice-Edouard Ngaïssona to the record of the case of Prosecutor v. Alfred Yekatom and Patrice-Edouard Ngaïssona and re-stamp all documents accordingly by no later than 1 March 2019 at 16h00, while maintaining their level of classification, until otherwise ordered;
- close the record of the case of *Prosecutor v. Patrice-Edouard Ngaïssona* once the abovementioned transfer of the documents is completed.

#### II. Classification

3. Pursuant to regulation 23bis(1) of the Regulations of the Court ("RoC"), two of the three annexes to the present submission are classified as "confidential" and "Under Seal, EX PARTE" respectively, because they contain information of a confidential nature.

4. The present submission is made pursuant to article 64(5) of the Rome Statute, rule 136 of the Rules of Procedure and Evidence and regulations 22 and 27 of the Regulations of the Registry.

## **IV. Submission**

- 5. Following the Decision, the Registry renamed the case *Prosecutor v. Alfred Yekatom and Patrice-Edouard Ngaïssona* on 22 February 2019 while retaining the case record number as ICC-01/14-01/18;
- 6. All documents in the case of *Patrice-Edouard Ngaïssona* have been transferred, registered and re-stamped in the record of the joint case *Prosecutor v. Alfred Yekatom and Patrice-Edouard Ngaïssona* as at 01 March 2019;
- 7. The Registry has maintained the level of classification of all documents;
