**PRE-TRIAL CHAMBER III** of the International Criminal Court issues this decision concerning the election of the Presiding Judge of the Chamber.

- 1. On 12 June 2019, the Prosecutor informed the Presidency of her decision to request judicial authorisation to commence an investigation into the situation in the People's Republic of Bangladesh/Republic of the Union of Myanmar (the 'situation in Bangladesh/Myanmar'), pursuant to regulation 45 of the Regulations of the Court ('Regulations').
- 2. On 25 June 2019, the Presidency constituted Pre-Trial Chamber III, composed of Judge Robert Fremr, Judge Olga Herrera Carbuccia and Judge Geoffrey Henderson, and assigned to it the situation in Bangladesh/Myanmar with immediate effect.<sup>2</sup>
- 3. The Chamber notes regulation 13(2) of the Regulations pursuant to which the judges of each Pre-Trial Chamber shall elect from amongst their members a Presiding Judge.
- 4. On 27 June 2019, the judges of the Chamber decided that Judge Olga Herrera Carbuccia will act as the Presiding Judge of the Chamber, with immediate effect.
