I. Introduction

1. On 24 January 2012, Pre-Trial Chamber I (“Chamber”) ordered the Registry’s Victims Participation and Reparations Section (“VPRS”) to report every three months on the applications received in the Situation in Libya (“Order”).¹

II. Applicable Law

2. The Registry submits the present report in accordance with article 68(1) and (3) of the Rome Statute, rules 16(1) and 89(1) of the Rules of Procedure and Evidence and regulation 86 of the Regulations of the Court.

III. Submission

3. From 24 April 2012 to 24 July 2017, the Registry submitted twenty-two reports on applications received by the VPRS in the Situation in Libya (“Situation”).
4. On 24 July 2017, the Registry noted in its Twenty-Second periodic report that no new applications have been received since the Registry’s seventeenth periodic report on applications received in the Situation and informed the Chamber that, unless instructed otherwise, it will suspend the transmission of periodic reports pending new developments in the Situation.²
5. On 13 September 2019, the Registry received one application for participation in any proceedings related to the Situation, bringing the number of

applications for participation in the proceedings received in the Situation to a total of nine.

6. The Registry moreover respectfully informs the Chamber that, unless instructed otherwise, it will again suspend the transmission of periodic reports pending new developments in the Situation.
