Pursuant to Pre-Trial Chamber A's Decision ICC-01/09-01/15-62 dated 11-12-2020, this document is transferred in case file ICC-01/09-01/20: The Prosecutor vs. Paul Gicheru

**JUDGE TOMOKO AKANE**, acting as President of the Pre-Trial Division of the International Criminal Court, hereby renders this decision on the 'OPCD Request for Leave to Appear on the Applicability of Provisional Rule 165' of 6 November 2020 (ICC-01/09-01/15-36).

**NOTING** the warrant of arrest issued on 10 March 2015 by Pre-Trial Chamber II against Mr Paul Gicheru ('Mr Gicheru') and Mr Philip Kipkoech Bett for offences against the administration of justice under article 70(1)(c) of the Rome Statute (the 'Statute');<sup>1</sup>

**NOTING** that, on 2 November 2020, Mr Gicheru surrendered himself to the authorities of the Kingdom of the Netherlands;

**NOTING** that, on the same day, Pre-Trial Chamber II requested the President of the Pre-Trial Division to constitute a Chamber to exercise the functions and powers of the Pre-Trial Chamber in the present case;<sup>2</sup>

**NOTING** the 'Decision Constituting a Chamber Composed of one Judge from the Pre-Trial Division to Exercise the Powers and Functions of the Pre-Trial Chamber in the Present Case' of 2 November 2020, by which the President of the Pre-Trial Division, acting under rule 165(2) of the Rules of Procedure and Evidence and regulation 66bis(1) of the Regulations of the Court, constituted Pre-Trial Chamber A (Article 70), composed of Judge Reine Adelaïde Sophie Alapini-Gansou, to exercise the functions of the Pre-Trial Chamber in the case of *The Prosecutor v. Paul Gucheru and Philip Kipoech Bett*<sup>3</sup> ('Composition Decision');

**NOTING** the 'OPCD Request for Leave to Appear on the Applicability of Provisional Rule 165' of 6 November 2020,<sup>4</sup> with which the Office of Public Counsel for the Defence requests that the President of the Pre-Trial Division 'recognise OPCD's mandate, as conferred in RoC 77(4), and grant leave to the OPCD to make submissions on the inapplicability of Provisional Rules 165(2) – and related RoC

> 66bis – in the present case seeking appropriate relief', so as to 'represent and protect the rights of Mr Philip Kipoech Bett, an unrepresented suspect in the case, and any potential suspects who are, or would be, subject to charges of Article 70';<sup>5</sup>

> **CONSIDERING** that the Composition Decision was taken as part of the functions of the President of the Pre-Trial Division pursuant to regulation 66bis(1) of the Regulations of the Court and that there are currently no proceedings concerning the case of The Prosecutor v. Paul Gucheru and Philip Kipoech Bett pending before the President of the Pre-Trial Division;

> CONSIDERING, therefore, that the President of the Pre-Trial Division has no power to rule on the substance of the Request;

# FOR THESE REASONS, THE PRESIDENT OF THE PRE-TRIAL DIVISION **HEREBY**

**REJECTS** the Request in limine.
