

### I. Introduction

1. The Registry hereby informs the Pre-Trial Chamber A that Mr Paul Gicheru has appointed Mr Michael G. Karnavas as Counsel to represent him in the proceedings before the International Criminal Court ("Court").

### II. Applicable Law

2. The following provisions are of particular relevance to the present submissions: article 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulation 67 of the Regulations of the Court, regulation 123 of the Regulations of the Registry and articles 5, 11 and 22(3) of the Code of Professional Conduct for counsel ("Code").

#### III. Submissions

3. On 17 November 2020, Mr Gicheru placed a telephone call to the Chief of the Counsel Support Section and indicated his will to appoint Mr Karnavas as Counsel to represent him before the Court.<sup>1</sup> On the same day, Mr Karnavas accepted the mandate, as required by article 11 of the Code.<sup>2</sup>
