HUMAN RESOURCES

As of 1st April 2011, the Court included 702 staff on established posts (348 professional staff and 354 General Service staff), 193 persons on General Temporary Assistance (GTA), 49 consultants or contractors and 93 interns or visiting professionals.

On 1st April 2011, staff subject to geographical representation were distributed as follows (in comparison with target figures):

- 16.35% from the Group of African States (target: 12.76%)
- 6.60% from the Group of Asian States (target: 18.36%)
- 7.23% from the Group of Eastern European States (target: 8.46%)
- 8.18% from the Group of Latin American and Caribbean States (target: 14.33%)
- 61.64% from the Group of Western European and other States (target: 46.09%)

75 nationalities are represented amongst the professional staff on established posts.

The Court takes care to ensure that male/female parity is maintained. On 1st April 2011, 48.31 % of the established professional posts are filled by women although more applications are received from men; in March 2011, 81.67% of the applications were sent by men.

Since the beginning of the year, the Court has received 2.011 applications for permanent or temporary posts. In 2010, the Court received applications from 10.346 individuals.

HEARINGS, DECISIONS AND FILINGS

Hearings

From 1 January to 31 March 2011, the Court held 65 hearings for a total of 217 hours (4 hearings for a total of 7 hours in the Lubanga case, 12 hearings for a total of 36 hours in the Katanga and Ngudjolo case, 48 hearings for a total of 173 hours for the Bemba case and one hearing for the initial appearance of Callixte Mbarushimana).

In 2010, the Court held 265 hearings for a total of 794 hours (96 hearings for a total of 268 hours in the Lubanga case, 142 hearings for a total of 471 hours in the Katanga and Ngudjolo, 21 hearings for a total of 46 hours for the Bemba case and 1 hearing in the Abu Garda case and 5 hearings for a total of 6 hours in the Jerbo and Banda's case).

Decisions and documents

Since the beginning of the year, 357 decisions, orders or judgments (representing 2,894 pages) including annexes were delivered, while 1,847 documents (representing 23,183 pages), including annexes, were registered.

In 2010, 1,059 decisions, orders or judgments (representing 9,901 pages) including annexes were delivered, while 7,403 documents (representing 123,376 pages), including annexes, were registered.

VICTIMS AND WITNESSES

Witness protection

The Registry organized and implemented all the necessary logistical arrangements for the unhindered and timely appearance of victims and witnesses at the seat of the Court. The services included organizing the safe movement of victims and witnesses; providing travel documents and assistance with immigration procedures; providing psycho-social and practical assistance in the field.

The Victims and Witnesses Unit facilitated the appearance of 60 witnesses in 2010 (33 for the Lubanga case, 24 for the Katanga and Ngudjolo case and 3 in the Bemba case) and 18 witnesses for the first three months of 2011 (1 for the Lubanga case, 3 for the Katanga and Ngudjolo case and 14 in the Bemba case)

On 31 March 2011, 59 witnesses or other person at risk on account of testimony participated in the Court's Protection Program in all situations. During the first quarter of 2011, 12 persons were assisted by the local protection measures.

In 2010, 983 travel and missions days were undertaken by the VWU field staff escorted witnesses and victims to the seat of the Court and in January, February and March 2011, the escort of the witnesses in the Bemba case requested 174 travel and missions days of the field staff.

Victim participation and reparation

Since investigations began, 4,773 victims have applied to participate in proceedings pertaining to situations (1,105 in the situation in the Democratic Republic of the Congo, 1,012 in the situation in Uganda, 208 in the situation in Darfur, 2,389 in the situation in the Central African Republic and 59 in the situation in Kenya), including 502 from 1 January to 31 March 2011 (461 in the situation in the Central African Republic, 37 in the situation in DRC and 4 in the Darfur) and 2,239 in 2010 (47 in the situation in the Democratic Republic of the Congo, 311 in the situation in Uganda, 63 in the situation in Darfur, 1,761 in the situation in the Central African Republic and 57 in the situation in Kenya).

Of the 4,773 victims, 2,317 were authorised by the relevant Chamber to participate in the proceedings.

Number of victims accepted to participate in the situations: 196 in the situation in the Democratic Republic of the Congo, 21 in the situation in Uganda, 11 in the situation in Darfur, Sudan.

Number of victims accepted to participate in the cases: 122 in the Lubanga case, 366 in the Katanga and Ngudjolo Chui case, 41 in the Kony et al. case, 1,366 in the Bemba case, 87 in the Abu Garda case, 6 in the Harun case, 12 in the Al Bashir case, and 89 in the Banda and Jerbo case.

A total of 1,386 applications were received for reparations from victims, including 739 in 2010 and 519 from January to March 2011

The Office of Public Counsel for Victims (OPCV) has been requested to provide to victims assistance, or/and representation with a significant increase in 2010, which has been already confirmed for the first trimester of 2011:

- Support and assistance are provided by the OPCV to 31 legal representatives in all situations and cases before the Court;
- 150 legal advice and research have been provided to external legal representatives;
- Legal assistance and representation are provided to 109 victims in the DRC situation or cases; 237 victims in the Uganda situation or case; 1556 victims in the CAR situation or Bemba's case; 23 victims in Darfur – Sudan situation or cases in accordance with the power of attorney signed by the external legal representatives;
- Legal assistance is also provided by the OPCV to around 100 victims in other countries.

The OPCV has published a manual for legal representative appearing before the Court, in English and French and a booklet explaining its role and mandate.

DEFENCE AND COUNSEL

Five suspects are detained at the ICC Detention Centre (Thomas Dyilo Lubanga, Germain Katanga, Mathieu Ngudjolo Chui, Jean-Pierre Bemba Gombo and Callixte Mbarushimana).

Indigence: Jean-Pierre Bemba Gombo has been declared not indigent while six other suspects were declared indigent (Thomas Dyilo Lubanga, Germain Katanga, Mathieu Ngudjolo Chui, Abu Garda, Abdallah Banda and Saleh Mohammed Jerbo).

List of counsel, assistants to counsel and professional investigators

Since the beginning of 2011, the Court has received 48 applications to be included in the list of counsel; 38 applicants were added to the list, bringing the total to 402 (93 women and 309 men) from 49 countries. The number of assistants to counsel has increased from 78 to 103 since 1 January 2011 and the list of professional investigators includes 28 investigators.

These recent figures could be explained as a result of the campaign to encourage African female lawyers to apply for admission to the list of counsel and the list of assistant, launched by the Registry jointly with the International Bar Association (IBA) in May 2010. In addition to the core objective to attract African female lawyers, the campaign has provided an opportunity to reach out to the legal communities in African countries. ICC Judges and senior officials addressed over 1000 lawyers at 17 events organised in partnership with local bar associations and civil society organisations.

The ninth edition of the Seminar of Counsel, which is organized annually by the Registry in accordance with the *Regulations of the Registry* is planned to take place on 16 and 17 May 2011 followed by a three-day training workshop.

The Office of Public Counsel for the Defence (OPCD) provides legal advice, memoranda and real-time assistance during court hearings (through access to real-time transcripts) to Defence Teams .

The OPCD was instructed by Trial Chamber III to assist the defence team of Jean Pierre Bemba in submitting observations on 1,233 victim applications.

OUTREACH and PUBLIC INFORMATION

In 2010 and 2011, respectively 157 and 40 press releases and advisory materials have been distributed while 1,339 and 379 interviews have been given by the officials of the Court. At the Headquarters of the Court, 571 visits were organized for a total of 10,302 persons in 2010; for the first three months of 2011, the number of visits has continued to increase with a total of 115 visits for a total of 2,232 visitors.

Outreach activities (meetings, workshops and seminars) are regularly carried out. In the course of 537 outreach sessions held in 2010, 53,263 participants received answers to their questions, while an estimated audience of nearly 70 million people was regularly exposed to Court information through local radio and television programmes. For outreach purposes the Court produced 98 radio programmes and 77 television programmes, including weekly summaries of the proceedings.

From January to March 2011, outreach activities took place as follows in the situation countries:

- Northern Uganda: during 29 interactive sessions, 2,047 people have been engaged directly.
- Democratic Republic of the Congo: during 29 activities, 2,824 people were directly engaged and an estimated audience of 25 million were regularly informed each month, through radio and television broadcasts.
- Central African Republic: during 24 interactive sessions 1,819 people were directly engaged and 800,000 people were regularly informed via the radio and television.
- Darfur: the activities have continued with the Sudanese diaspora, informing refugees in Eastern Chad and the media. 26 meetings have directly engaged 2,121 people. Through radio broadcasts and the posting of information on the Sudanese Online website, an estimated audience of 10 million have been regularly informed.
- Kenya: during 9 activities, 280 persons were directly engaged and an estimated audience of 20 million was informed through radio and television broadcasted on February and March 2011.

FIELD OPERATIONS

In 2010, 146 missions in Uganda received support and assistance from the Registry's Field Office Section (FOS). The office in Kampala was instrumental in providing assistance to the Court's staff on mission during the Review Conference of the Rome Statute. The Office was also instrumental in assisting increased work in other situations such as the Democratic Republic of the Congo and Kenya.

In the DRC, 396 missions undertaken by the Office of The Prosecutor, Registry defence teams and Trust Fund for Victims received assistance from FOS. Due to increased judicial activities and the arrest of Callixte

Mbarushimana, the Forward Field Office in Bunia assisted a number of missions in the two Kivu provinces. Additionally, 25 requests for judicial cooperation and assistance were notified and followed up by the Kinshasa Field Office.

In the Central African Republic, 82 missions were provided with support. With the commencement of the Bemba case, the Bangui Office assisted all the parties and participants in the proceedings. In addition, the Office notified 20 requests for judicial cooperation and assistance to the Ministry of Justice.

In January and February 2011, the Field Operations Section supported 198 missions (105 external missions and 93 internal missions) undertaken by the Office of the Prosecutor, Registry, defense teams and Trust Fund for victims, which represents an increase of 70 missions in comparison with the first two months of 2010.
