We have all read the statement published in Sudanese online from an anonymous source on 22/04/2013, it claimed that they are the family of martyr Saleh. Therefore we assure the world and local public opinion the following:

First: We are the family of the martyr Saleh; we did not publish any statement before, about the circumstances of the murder of our son.

Second: We confirm that everything contained in the substance of that statement, which was published completely bare of health

Third: We confirm that all of Muhammad Bashar and Arco Dahiya and Bakhit Dabjo did not have any involvement in the murder of our son and a number of his comrades.

Fourth: We emphasize that we have incontrovertible evidence that the party that assassinated our sons is the Justice and Equality Movement, the group of Jibril Ibrahim Mohammed, under his direct guidance and have we have also identified all leaders who planned and carried out the perfidious assassination, which killed a number of innocent lives and will we will revenge from them at any time.

Five: We are not from families who give birth to cowards and our son's bravely he appeared in front of the International Criminal Court in the Hague in June 2010 for the first time and continued to follow up with his lawyer Karim Ahmad Khan, until the date of his death, and that the scenario that has been created in that statement was merely a rumor intended to distort the history of our son and his struggles and therefore we believe that it is abusive to our dignity as a family because the martyr is now in the hands of his lord, while they are vandalize his history with lies. We have indentified source of the statement and where he resides and where he had published the statement for the first time.
