ANNEX 1

VICTIMS' VIEWS AND CONCERNS

This is an illustrative set of views and concerns expressed by 93 Victims communicated in person to the LRV during meetings with 702 Victims held in Kenya during the period 25 May to 17 June 2015. Views have been translated from the language in which they were spoken (usually Kiswahili, Luo or Luhya) to English.

The purpose of each meeting was primarily to update and inform the Victims of recent developments in the present case, including: the withdrawal of charges against Mr Kenyatta; the termination of the case by the Trial Chamber; the proceedings before the Appeals Chamber concerning the co-operation of the Government of Kenya; the March 2015 promise by Mr Kenyatta regarding compensation to victims of human rights abuses; the Prosecution's decision not to actively investigate; and the inactivity in Kenya of the Trust Fund for Victims. The Victims were informed that this was the last meeting which they would attend with the LRV. The Victims were also expressly invited to indicate whether they wished the LRV to file an application for review of the Prosecution's decision to cease active investigation. By overwhelming majority they expressed their support.

At each meeting, Victims were also given an opportunity to ask questions and to communicate any views or concerns they wished. An illustrative sample of those views and concerns appears below. This summary inevitably fails to convey the bitterness and anger with which many of them were communicated.

We suffered economic loss as a result of the property we lost and we cannot access healthcare. The Nyanza IDPs; have been deserted; even the local leaders do not bother anymore. Will the Court at least allow us to give our opinions in regards to this termination? There is so much we have to tell the Court and we feel they should listen to our grievances.

¹ Most Victims are Luo, Luhya or Kisii. A small number are Kikuyu women targeted for having Luo or Luhya husbands. The majority of the Victims, following their expulsion from Naivasha and Nakuru, went to the Nyanza and Western regions of Kenya where many now live in poverty. The population of Nyanza is predominantly Luo. The population of Western is predominantly Luhya. The perception that Kikuyu (and, to a lesser extent, Kalenjin) PEV victims have benefited disproportionately from Government assistance is a recurrent theme expressed by Victims. The term IDP ('Internally Displaced Person) is widely used within the victim community.

They even met with Bensouda and you never know if this is what led to the case being compromised. What we want to know, however, is if the case has been terminated, who is paying our lawyer? Where is that money coming from?
41.	a/8613/11	Male	You have informed us that there is an ongoing appeal. What does this appeal have to do with the victims? Can you please clarify if any action will be taken against Kenya if this appeal goes through?

The IDPs who remained behind in Rift Valley and in Nakuru were compensated and even their children have been taken to school. The IDPs from Nyanza equally have children and require assistance. We too have children who need to go school but we do not have the finances to pay for their school fees. My plea to you is that you connect us with donors and other people who can help us.

46.	a/9367/11	Female	I was a victim from Nakuru. All those victims who were residents of Nakuru were resettled. Those who came to upcountry in Nyanza region did not get any assistance from the Government.

However, we as the victims have not left the case, we are still part of this case. We have not given up. We should have been asked what our opinion was before the court terminated the case. We want to know who in particular abandoned this case.
