In light of the VWU observations to Prosecution request ICC-01/12-01/18-646-Conf-Exp, received via email ex parte (VWU and OTP only) on Friday 20 March 2020, the Single Judge finds it appropriate to seek supplementary information from the Prosecution, by 26 March 2020, concerning the situation of Witnesses [REDACTED] in view of the protection advice from VWU, notably to clarify whether [REDACTED] [REDACTED] The Single Judge further instructs the VWU to clarify, by 26 March 2020, when its initial protection assessments in relation to [REDACTED] were conducted; the specific reasons, related to the personal circumstances of both witnesses, underlying its recommendation to the Prosecution; and whether a further assessment has been or will be conducted in view of the Prosecution's reiterated intention to use them as witnesses.

Concerning Witnesses [REDACTED] [REDACTED] in view of the current situation, the Single Judge instructs the Prosecution to submit any update concerning [REDACTED] the situation of these witnesses by 26 March 2020.

The Single Judge is of the view that the supplementary observations hereby requested can be submitted on an ex parte basis and via email, should it be considered more convenient.

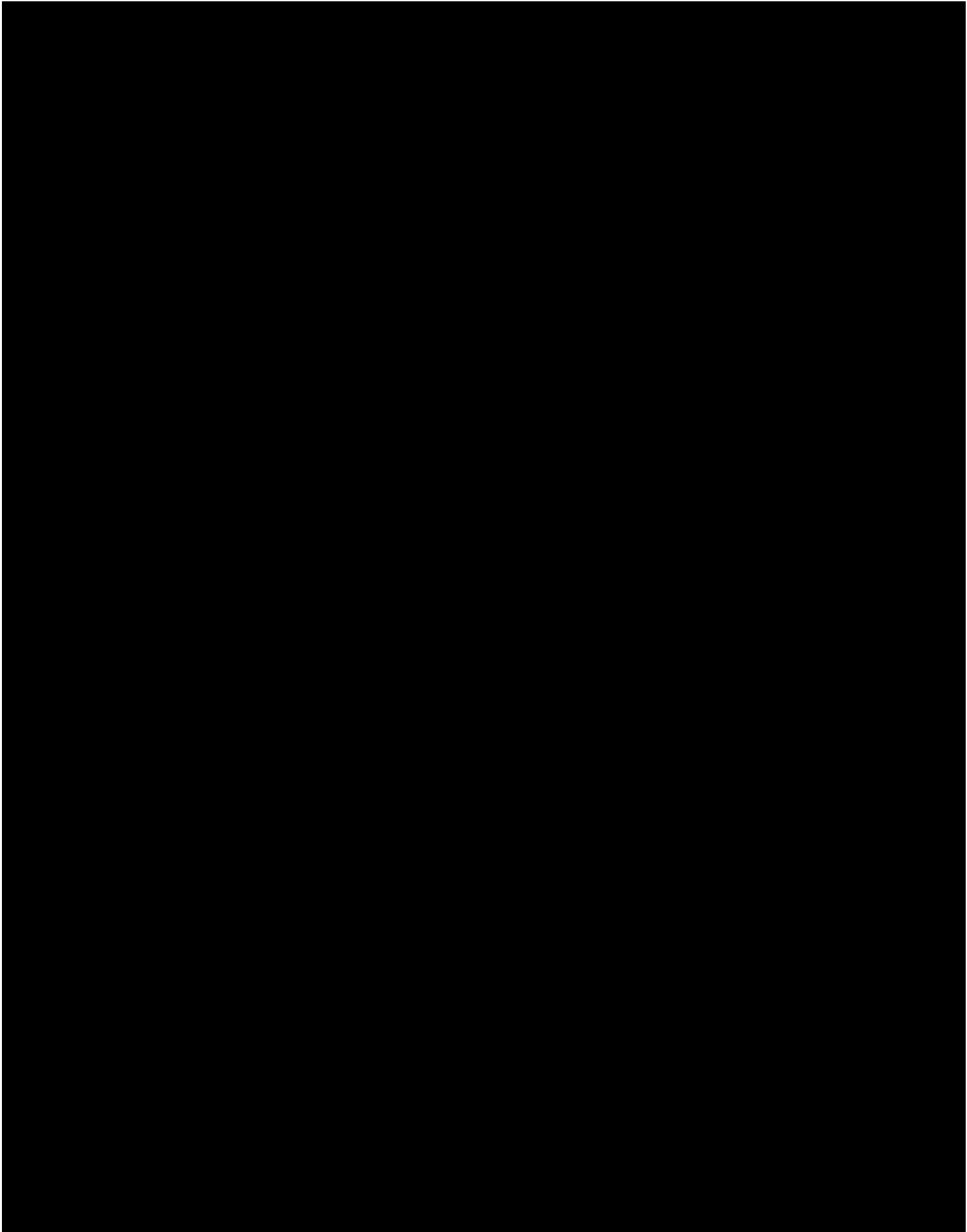
