Dear counsel,

The Chamber notes the Defence's request (filing -527-Conf-Exp) seeking an extension of time limit to respond to the Prosecution's request (filing -487-Conf-Red). Preliminarily, the Chamber notes that the Defence has filed its request as confidential ex parte, although it refers to the confidential redacted version of the Prosecution request. Accordingly, the Chamber instructs the Defence to file a redacted version of its request.

As regards the merits of the Defence's request, the Chamber notes that the extension sought is limited. The current deadline is on 16 December 2019 and the request seeks extension until 19 December 2019. The Chamber also observes that the Prosecution does not oppose the extension of time limit. Moreover, bearing in mind the parties' recent submissions in preparation for this week's status conference and the upcoming judicial recess, the Chamber considers that the Defence's request is reasonable.
