The Single Judge took notice of the Defence's *ex parte* submissions contained in Annex A to its submissions in preparation for this week's status conference (ICC-01/12-01/18-519-Conf-Exp-AnxA).

Preliminarily, the Single Judge wishes to inquire about the Defence's intention to make a version of its *ex parte* submissions available, in redacted form if required, to the Registry. For any of these issues to be addressed and acted upon, where appropriate, the Single Judge would find it most useful to have on the record of the case, and available to the Registry, the relevant Defence's submissions. To this effect, please let us know whether a version of ICC-01/12-01/18-519-Conf-Exp-AnxA can and will be made available to the Registry.
