It is anticipated that the International Criminal Court (ICC) located in The Hague, Netherlands, will shortly be issuing a solicitation for the provision of consultancy services to assess the Court's Headquarter Premises and establish capital replacement plans. ### Service description

The scope of the service agreement is the provision of consultancy services related to the assessment and evaluation of the Headquarter Premises of the International Criminal Court (ICC) in The Hague, Netherlands, the elaboration of medium and long-term capital replacement plans and recommendations on adequate structures for management and implementation.

The Court has moved into its new Headquarter Premises in 2015. The Court's Headquarter Building has an overall useful space of 56,000 m2 and is equipped with state of the art installations. The building has an office part for 1,000 staff, three courtrooms including cell areas, a conference centre, staff and visitors restaurant, library and media centre, exhibition centre, warehouse, a mirror pond, parking space and extensive landscape. The building is divided into public, secured and highly secured areas.

The ICC envisages that the contract will include but, is not limited to the following services:

- Building and property survey;
- Inspection report;
- Elaboration of medium and long-term capital replacement plans;
- Recommendations on contract, management and implementation structure.

The ICC is looking for a consultancy partner that is capable of providing the aforementioned services. The consultancy partner shall meet the following criteria to ensure that reports and advice will be provided from an experienced and objective position.

### Selection criteria:

- Fully qualified consulting firm specialized in property assessment;
- Proven experience in the establishment of capital replacement plans and life cycle planning;
- Experience in providing consultancy services to an international and/or governmental and/or other public institution;
- Capacity and ability to provide the services efficiently and effectively in a timely manner;
- Fluent English (written and spoken) of all team members.

Confirmation that the required services can be performed within the envisaged timeframe of between April and June 2023.

Confirmation that all team members will be able to communicate fluently in written and spoken English.
