In the appeal of the Bolivarian Republic of Venezuela against Pre-Trial Chamber I's "Decision authorising the resumption of the investigation pursuant to article 18(2) of the Statute" of 27 June 2023 (ICC-02/18-45),

SCHEDULING ORDER

A hearing in this appeal shall be convened on Tuesday and Wednesday, 7 and 8 November 2023 from 09h00 to 15h00. Further directions on the schedule and the conduct of the hearing will be issued in due course.

REASONS

I. PROCEDURAL HISTORY

1. On 27 June 2023, Pre-Trial Chamber I rendered its decision authorising the Prosecutor to resume the investigation into the situation in the Bolivarian Republic of Venezuela (hereinafter: "Venezuela"), pursuant to article 18(2) of the Statute (hereinafter: "Article 18(2) Decision").¹

2. On 3 July 2023, Venezuela submitted its notice of appeal against the Article 18(2) Decision.²

3. On 21 July 2023, the Appeals Chamber granted a request of the Office of Public Counsel for Victims (hereinafter: "OPCV"),³ and invited it to submit written observations on Venezuela's appeal brief in relation to the general interests of victims.⁴

4. On 14 August 2023, Venezuela filed its appeal brief (hereinafter: "Appeal Brief").⁵

5. On 24 August 2023, the Appeals Chamber granted, in part, the victims' requests,⁶ by allowing victims to make representations, with the assistance of their legal representatives if they so wish, and instructed the VPRS to collect and transmit to the Appeals Chamber representations from any interested victim and victims group, with the assistance of their legal representatives if they so wish, and submit a report thereon.⁷

6. On 13 September 2023, the Prosecutor filed his response to the Appeal Brief,⁸ and the OPCV submitted its observations.⁹

II. MERITS

7. The Appeals Chamber considers that, in addition to receiving written submissions in the proceedings at hand, it is appropriate to also convene a hearing in accordance with rule 156(3) of the Rules of Procedure and Evidence in order to fully address the novel and complex issues that arise in this appeal.

8. At this hearing, the Appeals Chamber will give the parties and participants an opportunity to address specific issues arising from their submissions and to respond to questions that may be posed by the Appeals Chamber. Given the OPCV's involvement
