

### I. SUBMISSIONS

- 1. On 22 July 2022, Pre-Trial Chamber II ("Chamber") ordered the Prosecution to 'provide submissions as to the possibility of either reclassifying the Warrant of Arrest¹ and the 25 March 2021 Decision² as public or submitting confidential versions of these documents in the record of the present case by no later than 28 July 2022, together with any proposals and justifications for redactions if applicable' ("Order").³
- 2. In respect of the Warrant of Arrest, the Prosecution submits that, concurrent to the Order, on 22 July 2022, it has requested the Chamber to unseal the Warrant of Arrest in the Situation and to issue a public redacted version of it as proposed in an annex to its request, justifying the need for these redactions ("Request").<sup>4</sup> The Prosecution trusts that the Request satisfies the Chamber's Order.
- 3. In respect of the 25 March 2021 Decision, the Prosecution has no objection to its reclassification as public in the Situation, upon the Chamber's issuance of the public redacted version of the Warrant of Arrest.

### II. CONFIDENTIALITY

4. These submissions are filed "Under Seal, *Ex Parte*, only available to the Prosecution and Registry" in accordance with regulation 23bis(2) of the Regulations of the Court as they respond to an order with the same classification. The Prosecution does not object to its reclassification as public, upon the Chamber's issuance of the public reducted version of the Warrant of Arrest.
