I. Introduction

1. The present submissions are filed pursuant to Pre-Trial Chamber II's ("Chamber") "Order to the Prosecution and the Registry for Submissions regarding the Warrant of Arrest against Mahamat Nouradine Adam"¹ ("Order") dated 22 July 2022.
2. In the Order, the Chamber "*orders the Prosecution and the Registry to provide submissions as to the possibility of either reclassifying the Warrant of Arrest and the 25 March 2021 Decision as public or submitting confidential versions of these documents in the record of the present case by no later than 28 July 2022. Should the Prosecution and/or Registry consider that redactions should be applied to the Warrant of Arrest and/or the 25 March 2021 Decision for these purposes, they shall also provide specific proposals and justifications to this end*"².

II. Classification

3. Pursuant to regulation 23 *bis*(2) of the Regulations of the Court, the present document is classified as under seal *ex parte* only available to the Prosecution and the Registry in line with the classification level of the Order. However, the Registry does not oppose its reclassification as public, should the Chamber so decide.

III. Submissions

4. The Registry submits that it does not oppose the reclassification of the Warrant of Arrest for Mahamat Nouradine Adam³ and that of the Chamber's Decision
