I. Introduction

- 3. On 27 September 2022, the Registry transmitted a cooperation request to Kenya, requesting them to confirm Mr Gicheru's death and provide a death certificate for onward transmission to the Chamber.

III. Classification

4. In accordance with regulation 23bis(1) of the Regulations of the Court, the present submission is classified as confidential as it refers to information provided by the Kenyan authorities, for which the classification is pending. Annex I is classified as confidential Ex Parte only available to the Registry, pending confirmation of the classification of the document by the Kenyan authorities especially with respect to the burial permit.
