I. Introduction

1. The Registry submits with the present report and its 38 annexes, the public and confidential versions of email decisions pursuant to the “Directions on the conduct of proceedings”¹ (“Directions”), issued on 9 March 2022 by Trial Chamber VI (“Chamber”).²

II. Procedural History

2. On 9 March 2022, the Chamber issued the Directions instructing the Registry to file all email decisions on the case record in quarterly reports³, which also should comprise the decisions issued up to the publication date of the Directions.⁴
3. The Chamber further directed the parties and participants to: i) frame their requests made by email in a way that make their publicity possible; and ii) indicate in the email when emails cannot be made public at all.⁵
4. On 10 August 2022, the Chamber approved the Registry’s proposal to file a consolidated single report *in lieu* of the first two quarterly reports for email decisions issued from the date of constitution of the Chamber until the end of June 2022.⁶

III. Classification

V. Submissions

7. In the Directions, the Chamber provided criteria for the application of the redactions to the email decisions. The Registry was instructed *inter alia* to apply redactions to i) names of Chambers staff members, where applicable; ii) names of Registry staff members, if deemed necessary by the Registry; and iii) any personal email address or other private or personal information. The Registry shall consult the parties and participants on the redactions applied.⁷

8. Accordingly, the Registry applied redactions to emails set forth in the following 38 annexes:


