I. Introduction

1. The Registry submits the present report (“Registry Report”) and its two annexes consisting of a confidential version of items recognized as evidence formally submitted and its public redacted version, pursuant to the “Directions on the conduct of proceedings” (“Directions”),¹ issued on 4 October 2021 by Trial Chamber I (“Chamber”).

II. Procedural History

2. On 4 October 2021, the Chamber issued its Directions, in which it directed the Registry to: “[...] reflect all formally submitted items in the eCourt metadata [...]”, and to “[...] submit reports for each witness who testifies, indicating which items have been formally submitted by the parties and participants in relation to that witness. The email exchanges [...] are to be annexed to this filing, applying redactions as appropriate”.²
3. On 5 September 2022, the Office of the Prosecutor (“Prosecution”) called its thirty-first witness. After the conclusion of the examination of witness P-0916, parties formally submitted items used during the hearings as instructed in the Directions.
4. On 20 September 2022, the Chamber issued the decision on items of evidence recognised as formally submitted for witness P-0916 via email.³ Pursuant to the Directions, the Registry was instructed to apply redactions as appropriate to the emails enclosed in Annex 1 to the filing.



5. For the purpose of the present submission, the Registry has considered *inter alia* articles 64(7), 64(10) and 67(1) of the Rome Statute and rule 137 of the Rules of Procedure and Evidence.

IV. Submission

6. The Registry hereby attaches confidential Annex 1:
- **Annex 1:** "Decision on the submission of material through P-0916."
7. In order to enable the parties and participants to suggest specific additional redactions to Annex 1, the Registry liaised by email with the Prosecution, the Defence, and the Legal Representatives of the Victims.⁴ Further redactions were proposed by the parties.⁵
8. Accordingly, the Registry applied redactions to the emails set forth in the following public redacted version of Annex 1: "Decision on the submission of material through P-0916", dated 20 September 2022 at 12.57.
