- 3. The Prosecution hereby submits its Witness Table comprised of two annexes:
 - Annex A, which contains the relevant documents and information for each witness pursuant to the Chamber's order;³ and
 - Annex B, which contains the elements the Prosecution intends to prove by relying on each of these witnesses pursuant to the Chamber's order.⁴
- 4. The Prosecution notes that in line with the Chamber's order to disclose only "evidence of true relevance",⁵ the Prosecution has not disclosed all the items (audio/video recordings, photographs, and meta-data) provided by witnesses P-0342, P-1576, P-1577, P-2012 and P-2377, but only a selection thereof.
