NOTING the “Requête urgente du Bureau du Procureur aux fins d’une ordonnance de la Chambre en application de l’article 56-2-d pour l’interview du témoin MLI-OTP-P-0111”, filed by the Office of the Prosecutor on 15 October 2014;¹

NOTING the “Décision concernant la “Requête urgente du Bureau du Procureur aux fins d’une ordonnance de la Chambre en application de l’article 56-2-d pour l’interview du témoin MLI-OTP-P-0111”, issued by Pre-Trial Chamber II on 15 October 2014;²

CONSIDERING that the Registry was instructed to designate a lawyer, at the earliest possible opportunity, in conformity with paragraph 7 of the decision and to notify, at the earliest opportunity, the documents mentioned in paragraph 8 of the decision, if need be in redacted form, as submitted by the Office of the Prosecutor, as well as the decision of 15 October.³

CONSIDERING that the Registry was ordered to provide the Chamber with a report on the implementation of the decision of 15 October 2014 at the earliest opportunity.⁴

NOTING Regulations 24*bis* and 23*bis* of the Regulations of the Court;

HEREBY TRANSMITS, respectfully, the report below. The relevant documentation (Curriculum Vitae, the letter of appointment and the forms required by article 5 and 22 of the Code of Professional Conduct for Counsel) is annexed as a Confidential *ex parte* annex, only available to the Office of the Prosecutor, to this present document.

1. Following the notification of the Decision ICC-01/12-18-Conf-Exp, the Registry proceeded to identify the lawyers who would meet the criteria set by the Single Judge in paragraph 7 of the Decision.
2. On 16 October 2014, the Registry contacted [REDACTED], a lawyer [REDACTED], and inquired on his availability to accept the mandate of the Chamber. After he confirmed his availability, the Registry sent him the appointment letter, annexes thereto and the two forms required by article 5 and 22 of the Code of Professional Conduct for Counsel.
3. On 17 October, the Counsel Support Section received the signed letter of appointment for [REDACTED] as well as the signed forms required by articles 5 and 22 of the Code of Professional Conduct for Counsel.
4. On 17 October 2014, at 15.09 hours, the Court Management Section (CMS) notified [REDACTED] of documents ICC-01/12-17-Conf-Exp-Red, ICC-01/12-17-Conf-Exp-AnxA and ICC-01/12-18-Conf-Exp. The same day, the CMS sent hard copies of the said documents *via* DHL [REDACTED]. On 20 October 2014, at 23.20 hours, [REDACTED] acknowledged receipt of the documents sent to him by DHL.
