Judge Raul C. Pangalangan, acting as Single Judge on behalf of Trial Chamber VIII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court issues the following 'Decision on Joint Request for an Extension of Time to File a Public Redacted Version of ICC-01/12-01/15-78-Conf-Exp-Anx1', in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, having regard to Regulation 35(2) of the Regulations of the Court.

- 1. On 24 May 2016, the Chamber set a deadline of 17 June 2016 for the filing of a public redacted version of the agreement regarding the admission of guilt and agreed factual basis thereto (ICC-01/12-01/15-78-Conf-Exp-Anx1).¹
- 2. On 13 June 2016, the Office of the Prosecutor and Defence jointly requested an extension until 19 August 2016 to file this public redacted version ('Request').²
- 3. For the reasons provided by the parties, the Single Judge decides that there is good cause to grant the Request.

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

GRANTS the Request, directing that a public redacted version of ICC-01/12-01/15-78-Conf-Exp-Anx1 must be filed by 16:00 on 19 August 2016.
