I. Introduction

- 1. On 20 May 2016, the Registry received three applications to participate in the proceedings related to the case *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, which were given reference numbers a/35000/16, a/35001/16, and a/35002/16 ("Applications").
- 2. On 23 May 2016,¹ Trial Chamber VIII (the "Chamber") ordered the Registry to transmit the Applications, by 25 May 2016, in unredacted form, to the Chamber, the Office of the Prosecutor and the Office of Public Counsel of Victims, and in redacted form to the Defence. The Registry did transmit the Applications accordingly.²
- 3. On 8 June 2016, the Chamber issued a decision on victim participation and legal representation of victims at trial, whereby the Applications were admitted for participation in the proceedings, and directed the Registry, *inter alia*, to file public redacted versions of the Applications within 10 days of notification of its decision ("8 June 2016 Decision").³
- 4. The Victims Participation and Reparations Section, in consultation with the Legal Representative of Victims and the Victims and Witnesses Unit, prepared public redacted versions of the Applications in accordance with the 8 June 2016 Decision.
