Judge Raul C. Pangalangan, acting as Single Judge on behalf of Trial Chamber VIII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court issues the following 'Decision on LRV's request for clarification of procedure applicable to newly collected reparations applications', in the case of *The Prosecutor v. Ahmad Al Faqi Al Mahdi*, having regard to Article 75 of the Rome Statute ('Statute'), Rule 94 of the Rules of Procedure and Evidence ('Rules') and Regulation 35 of the Regulations of the Court ('Regulations').

I. Background and Submissions

- 1. On 29 September 2016, the Chamber issued the Reparations Phase Calendar, setting 16 December 2016 as the deadline for filing applications for reparations ('Application Deadline')¹ and 11 January 2017 as the Deadline for Submission of Additional Material.² The Chamber explicitly specified that 'the [A]pplication [D]eadline is without prejudice to whether or how these applications will be ultimately considered by the Chamber'.³
- 2. On 16 December 2016, the Registry transmitted 135 applications for reparations.⁴
- 3. On 20 March, upon two requests from the Legal Representative of Victims ('LRV'),⁵ the Single Judge authorised the LRV to file any newly collected reparation applications by the Deadline for Submission of Additional Material which had been postponed to 24 March 2017 by way of a 19 January 2017

decision.⁶ In the same decision, the Single Judge rejected the request for extension of the Deadline for Submission of Additional Material to 28 April 2017.⁷

- 4. On 18 May 2017, the LRV filed a request for clarification of the procedure in place for the filing of newly collected reparations applications ('Request').⁸ The LRV submits that the Chamber did not pronounce on such a procedure and requests that it be set up urgently and that a deadline for transmission be set.⁹
- 5. No responses were filed.

II. Analysis

6. On 29 September 2016, the Chamber set 16 December 2016 as the Application Deadline, namely the deadline for the submission of any reparations applications collected within that period. In the same order, the Chamber specified that the Application Deadline was 'without prejudice to whether or how these applications will be ultimately considered by the Chamber'. Accordingly, the procedure and deadline for submission of applications are clear from the plain text of the Reparations Phase Calendar and no further clarification is required. 11

It is noted that the procedure set by Trial Chamber VIII is perfectly in line with the Trial Chamber II's decision referred to in the Request, which precisely set an application deadline for newly collected applications. (Request, ICC-01/12-01/15-220-Conf, para. 14 referring to *The Prosecutor v. Germain Katanga*, Trial Chamber II, Decision on the "*Demande de clarification concernant la mise en oeuvre de la Règle 94 du Règlement de procédure et de preuve*" and future stages of the proceedings, 8 May 2015, ICC-01/04-01/07-3546-tENG).

7. Additionally, it appears that this procedure was also clear to the LRV when he sought authorisation to file applications collected after the Application Deadline, explicitly specifying that '[TRANSLATION] [he] is well aware that, in its decision ICC-01/12-01/15-172 of 29 September 2016, the Trial Chamber set to 16 December 2016 the deadline to transmit all applications for reparations'. 12

8. To the extent that the Request can be read as a further request for extension of time of the Application Deadline, the Request equally ought to be rejected as overly broad and lacking any justification. The Single Judge recalls that, on 20 March 2017, in the decision authorising the LRV to file the reparations applications collected after the Application Deadline, he already rejected a four-week extension of time for filing said applications and supporting materials on the basis of the speculative nature of the request and of the lack of specificity of the reasons advanced. At this stage of the reparations proceedings, unless exceptional circumstances are shown, no further request for extension of the Application Deadline will be entertained, noting in particular that final reparations submissions are due on 16 June 2017.

FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY

REJECTS the Request; and

DIRECTS the LRV to file a public redacted version of the Request within two days of notification of the present decision.
